To design and manufacture products should be our motto, in such a way we will help Mother Africa to take her place on the global stages. I am glad that we have various stakeholders namely researchers, manufacturers, suppliers, service providers, Civil Society Organisations and representatives of OPDs from Southern Africa and beyond on this webinar-through our interaction, we can and will create a better world.

Allow me to pause for a moment and share with you the story of Rob Smith from England, founder of the business ACTIVE HANDS. I read about him on the internet.

Rob was just 20 years old when he fell down a cliff, which left him with a spinal cord injury and partial paralysis in all four limbs. One of the things he struggled with was picking up and gripping things, which made everyday tasks much more complicated.

With the help of his mother and her sewing machine, he started to make his own gripping aids- simple sleeves that he could put over his hand and tighten to help him make a fist and grip items. When some of his wheelchair ruby teammates wanted to use them too, he realised he had a business idea and founded *Active hands*, which is now a thriving family business selling to people all over the world. The reason why I am telling this story, is to encourage you that persons with disabilities can guide you best in what they need, you never have to run out of ideas. Sit next to people with disabilities and those taking care of them, teaching them and you will hear the needs and you can be the solution to those needs. And when you employ people to make these devices, include persons with disabilities in the various processes.

I am glad that the research "The 2020 Mobile Disability Gap" will be shared with us. Research is indeed one of our cornerstones to advance the course of people with disabilities. In the National Disability Mainstreaming Plan for Namibia, which was launched in 2020, we have 12 theme, and the 10<sup>th</sup> theme reads as follows: *Promote Disability Research by and with persons with Disabilities to Monitor and Report on Progress of the UN Convention on Persons with Disabilities Targets.* This theme is driven by Article 31 of the UNCRPD which is titled: *Statistics and Data Collection*, as well as Article 22 of the African Union Protocol to the African Charter on Human and People's Rights on the Rights on the Rights of persons with Disabilities in Africa.

Furthermore, I am impressed with the innovations such as rechargeable hearing aid batteries, the Signcoach app that teaches the Botswana Sign language and other that we will learn more about over the next two days. It is indeed so important that designers and manufacturers must enjoy our support. Your noble aim to uplift the living standards of people with disabilities is heart-warming. We must work strategically and intentionally if we want to make a difference, and I can see that you are already doing so.

I would like to echo the call of the 2030 Agenda for Sustainable Development to leave no one behind. To the organisers, through webinars such as this, you are already doing this and in such a way, you are strengthening the efforts of the Government in Southern Africa to uplift marginalised groups of people, such as the people with disabilities.
